Signs: The symptoms of intestinal blockage include intermittent discomfort, cramping, stomach swelling, irregularity, bloating, and throwing up.

**Diarrhea** could occur in case the small intestine is partially blocked.

Likewise, pets experiencing kidney or liver issues, muscle weakness or glaucoma are considered unsuited for Xanax dosage. In any case, talk to your vet about your family pet's pre-existing condition, and talk about whether it would be suitable to administer the drug in such circumstances.

Irritable Bowel Syndrome (IBS) is a condition of the gastro-intestinal system, leading to issues in either the upper or lower intestine. - To avoid these withdrawal impacts, it is best to put your pet on very little dose of Xanax that too for a shortest possible period.

### Particular Foods can Activate or Intensify IBS Symptoms

These foods include fatty foods such as fried food, dairy items, chocolate and alcohol. Caffeinated drinks such as coffee or carbonated beverages can act as a laxative to some people, yet for IBS victims caffeine can act to distress their digestive system. Individuals with IBS are recommended to eat foods which are high in fiber, such as fruit, beans and other vegetables, whole-grain cereals and whole-meal bread.
